

Thema Collection Sets Sustainability Benchmark with GHG Quantification Initiative

Thema Collection, an eco-conscious hospitality group in Sri Lanka, has partnered with Australia's Market Development Facility (MDF) to carry out a pioneering sustainability initiative. This project quantifies the Greenhouse Gas (GHG) emissions from its properties and is the first comprehensive GHG assessment conducted for an entire hospitality chain in Sri Lanka.

A third-party verification by the National Cleaner Production Centre (NCPC), Sri Lanka confirmed compliance with ISO 17029:2019, ISO 14064-3:2019, and ISO 14064-1:2018 standards. This process improved data accuracy, identified key improvement areas, and laid a strong foundation for future GHG assessments and emission reduction strategies.

"Our partnership with MDF enabled us to take a critical step forward in our sustainability journey. By quantifying our GHG emissions, we now have the data and direction needed to reduce our climate impact and foster a low-carbon tourism model," said Chandra Wickramasinghe, Chairman/MD, Thema Collection.
